Office Updates:

- Building Permit Inspections Zach has finished all of the Building Permit Inspections. Jane and Kelly have been busy entering all the information into Vision.
- KRT Sales Analysis Kelly informed the Board that the Sales Analysis was delayed because we were having issues with the computer that Ken remotes from. The computer had to be replaced and some software was added. Kelly will also contact Entre to get the Sleep mode off of the computer.
- New Growth Kelly will be calculating the New Growth these next couple of months and will have an update for the next meeting.

It was not changed on the Forest Management Plan until it was renewed for FY2025. Kelly has corrected the acreage in Vision. Jane will have a new Lien ready for the Board to sign at the next

- O Pafumi (9-33-1 & 9-7-1) Parcel ID 9-7-1 was added to the Forest Management Plan for Fiscal Year 2025. The parcel was previously in Chapter 61B. Jane will have a new Lien ready for the Board to sign for parcel ID 9-7-1 to change the Program from 61B to 61. Mr. Charest made a motion to approve the renewal application.
